

1. Reference PIO/NHRC vide R.C.No.16(I)/PIO/2005(RTI)/5378 dated 28/09/2011 enclosing therewith a copy of the above mentioned application.

2. On perusal of the application it is seen that applicant is seeking various information about the complaints of human rights violation received from the areas where AFSPA, is imposed and about the action taken by the Commission on these complaints.

3. In this regards it is to inform that only first, second and sixth paras of the RTI application pertain to the Law Division. In respect of other paras, POI may like to seek the information from Investigation, Coord Division as well as PRP&P Division. In respect of number of the complaints of Human Rights violations received from the areas where AFSPA is imposed, it is to inform the Commission does not categories the complaint received on the basis of the areas where AFSPA is imposed. All complaints received in the Commission are registered and state wise categorized under Complaint Management Information System. It is further to clarify that those complaints which do not involve any specific human rights violations are also registered, but dismissed in limini.


4. However, the state wise details of the number of complaints registered by the Commission during the last 3 years, is as per Annexure A.

The complaints, of which the Commission take cognizance, ordinarily are either transferred to the SHRC or disposed of with direction to the authority concerned for appropriate action or call, the Commission for the report from the authorities concerned for appropriate action and, wherever deemed necessary, makes appropriate recommendations as per the Act on consideration of these reports.

5. In respect of para (vi) relating to Irom Sharmila, it is to inform that the Commission took suo-motu cognizance in the matter vide Case No 24/14/4/2011-WC and called for a report from the Chief Secretary, Govt of Manipur. Pursuant to the Commission's directions, the Additional Secretary (Home), Govt of Manipur submitted a report to the Commission. On perusal of report the Commission vide its proceedings dated 13.4.2011 closed the case. Further, the Commission received two complaints dated 03.09.2011 and 08.09.2011 from Smt Shanti Devi Brahman and Mr Radhakanta Tripathy respectively and disposed of the complaints with directions to transmit the complaints to the authority concerned for appropriate action vide its order dated 05/10/2011 and 13/10/2011 in case No 89/14/4/2011 and 95/14/0/2011 respectively. Accordingly both the complaints were transferred to the Secretary, Ministry of Home, Govt of India, North Block, New Delhi.

6. The above information is submitted for further necessary action of PIO.

Order

The Manipur State Human Rights Commission, Imphal, forwarded a copy of the proceedings dated 1.4.2010, and pursuant to that the National Human Rights Commission took cognizance of the matter on 1st July, 2010 and directed to call for a report from the Secretaries of the Ministries of Environment & Forest and Home Affairs, Government of India within eight weeks. This matter relates to the Loktak Lake, one of the largest fresh water lakes in the North-Eastern Region. This lake is affected seriously by a phenomenon locally called "Phumdis". These are a heterogeneous mass of soil, vegetation and organic matter at various stages of decomposition, which get collected in the lake and these are to be removed. There is also allegation that the Loktak lake is being encroached upon by the neighbouring people. A contract was entered into for the removal of 'Phumdis' to save the lake. There is a Loktak Development Authority to manage the affairs of this lake. As per the contract the work has to be completed till March 2011. The Commission would like to know what steps have so far been taken by the contractor in carrying out this obligation in the contract. A Senior Officer of the NHRC would go and get first hand information about the present state of affairs of the lake and also the nature of the work carried out by the contractor. The Government of Manipur is directed to render all assistance to the Officer in discharging his duty. A report be submitted within eight weeks after the study done by the Officer of the NHRC.
